# **Strategic Domain Acquisition & Registrar Accountability Terms**

Issued by: Robust Business Core AI Inc. (RBC AI)

Date of Publication: April 14, 2025

#### 1. Scope & Applicability

These terms apply to all domain acquisitions, renewals, or related digital services purchased or initiated by RBC AI Inc. from any registrar, service provider, platform, or intermediary. By executing any transaction with RBC AI Inc., the provider explicitly or implicitly agrees to the terms herein unless expressly rejected prior to transaction.

### 2. Supremacy of RBC AI Terms

The provider acknowledges that RBC AI Inc. does not accept external Terms of Service, Privacy Policies, or EULA agreements unless a clear and documented consent action is performed (e.g., clicking 'I Agree' on a legally binding interface). Absence of such explicit consent renders the provider's terms inapplicable to the transaction.

### 3. Registrar Transparency Obligations

- 3.1. The registrar must, upon request and without unreasonable delay, provide the following data for any domain purchased by RBC AI Inc.:
- Registrar chain of custody
- Ownership transition metadata (WHOIS snapshot logs)
- DNS history and zone file diff reports
- Backend registrar activity logs (if anomalies are detected)
- Domain reputation reports, legal claims, or third-party restrictions
- DNSSEC validation chain and key integrity status
- Cloud DNS access control logs (if managed by registrar)
- Compliance records with NIST or equivalent domain security frameworks
- 3.2. Failure to disclose or preserve the above data shall constitute grounds for:
- Legal dispute escalation
- Regulatory complaint submission (to ICANN, CIRA, FTC, or relevant authorities)
- Formal demand for service reversal or refund

#### 4. Non-Cancellation Clause

The registrar or platform may not unilaterally cancel, suspend, or revoke any domain purchased by RBC AI Inc. without:

- Prior written notification and 14-day dispute window
- Explicit legal reasoning or external regulatory order
- Transparency on the initiating party of any takedown action

Violation of this clause constitutes a breach of commercial terms and may trigger public and legal escalation mechanisms.

### 5. Security & Technical Guarantees

RBC AI Inc. expects that:

- All domains are protected from unauthorized access, hijacking, DNS manipulation, or internal registrar misuse.
- If any breach or systemic failure affects domain integrity, the registrar must notify RBC AI Inc. within 24 hours.
- If registrar manages cloud DNS, access controls and changes must be logged and retrievable.
- Any DNSSEC failure or mismatch must be reported and remediated immediately.

The registrar agrees to indemnify RBC AI Inc. from damages resulting from technical misconduct, negligence, or systemic failures.

## 6. Jurisdiction & Legal Remedies

These terms are governed under Canadian commercial law and aligned with international digital rights principles. In case of unresolved dispute:

- Arbitration may be initiated under ICC rules or regulatory boards
- RBC AI Inc. reserves the right to publish dispute details for transparency
- Registrar agrees to comply with third-party investigations or audit requests
